**DIRECTIONS**: The grounds are at Baker Farm, 1262 Kersten Road, Sealy, TX 77474. I-10 heading west from Houston take exit #721 and take the first left under the freeway. At the "T" turn right, this is a two-way service road, go to the second street and turn left, onto Kersten Road. Go 1.1 mile to the log house on the left. Parking is through the opening in the fence on the left side down the driveway, park behind the clubhouse in the field.

**SITE DETAILS**: There is a lovely clubhouse at this site, but the walk to the field is rather long. You may wish to plan to bring an easy up or extra crates or secure expens to hold your dogs near the field gate in case of stake conflicts. **We will not be renting golf carts**. We will help exhibitors get extra crates or equipment to the back part of the field.
