## NEW LOCATION, NEW LOCATION – SEALY, TX

**DIRECTIONS:** The grounds are at Baker Farm, 1262 Kersten Road, Sealy, TX 77474. I-10 heading west from Houston take exit #721 and take the first left under the freeway. At the "T" turn right, this is a two-way service road, go to the second street and turn left, onto Kersten Road. Go 1.1 mile to the log house on the left. Parking is through the opening in the fence on the left side down the driveway, park behind the clubhouse in the field.

**SITE DETAILS:** There is a lovely clubhouse at this site, but the walk to the field is rather long. You may wish to plan to bring an easy up or extra crates or secure expens to hold your dogs near the field gate in case of stake conflicts. **We will not be renting golf carts.** We will help exhibitors get extra crates or equipment to the back part of the field.

**ENTRY FEE:** \$20.00 per entry for all stakes. No charge for Best Of's or Absolute. **Make checks payable to Bayou Dachshund Club for BOTH TRIALS.** Be sure to bring your dogs' entry information with you. Dogs must be present on the grounds at the time entries close to be officially entered. You may copy the enclosed form if you need more forms. **DO NOT mail entries in advance.**

**RUNNING ORDER:** Classes will run concurrently with OAAD & FCD, followed by OAAAB & FCB, as the field becomes available, then Best Open, Best Field Champion, and Absolute. Be prepared for this running order. Judges will not wait for dogs except as provided for in the AKC rule book. The committee reserves the right to make changes to the running order to expedite the event.

**DRESS:** Bring proper gear. The trial will be run, rain or shine.

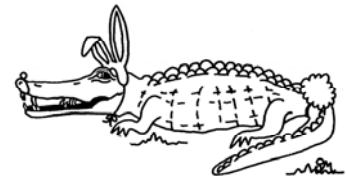

We will have a little competition for the Top Swamp "Rabbit" Chef or Chefs. All dishes must be prepared by you (not store bought). Store bought components may be used like Cake Mixes, Prepared meats, bottled sauce (that you have changed of course!), etc. But you have to prepare the rest of the dish as an original recipe. You must bring with you a small sign with the Name of your Swamp "Rabbit" dish, your name and one copy of the recipe of how you put your dish together. **We ask that you pre-enter your dish by December 15, 2008.** E-mail your name, and the Real Name and your Swamp Rabbit Name of your dish to Randy (info above). **Naming your dish:** All Dishes need to have Swamp Rabbit in the name. For instance, instead of Glazed Carrots, your dish could be Swamp "Rabbit" Carrots or instead of Chips and Chive Dip, it would be Chips and Swamp "Rabbit" dip.

Keep in mind that Kitchen facilities are VERY limited. Our Top Cajun Chefs will be on hand to provide Tea, Bowls, Plates, Napkins, and Utensils. (Bring your own serving utensils or other drinks).
